2025 Indiana Missing Children’s Day Poster Contest

The Indiana State Police is proud to partner again in 2025 with the U.S. Department of Justice in promoting the National Missing Children’s Day Poster Contest. In 1983, President Ronald Reagan proclaimed May 25th as National Missing Children’s Day. This day is dedicated to encouraging parents, guardians, caregivers and all concerned individuals with the well-being of children to make child safety a priority.

It serves as a reminder to continue our efforts to reunite missing children with their families and loved ones. It also serves as an occasion to honor those who are dedicated to this very noble cause. The National Missing Children’s Poster Contest provides an opportunity for schools, law enforcement, and parents/guardians to discuss and promote child safety.

The state winner will receive a national award certificate from the U.S. Department of Justice and their poster will be selected to go to the national judging competition. The national winner, along with his/her parents and teacher, and the state manager will be invited to Washington, D.C. to participate in the U.S. Department of Justice’s National Missing Children’s Day ceremony.

OUR PURPOSE

To provide healthcare and educational communities resources to aide in the recovery of unidentified or missing persons. There are over 1,000 missing persons in Indiana’s Law Enforcement database. Together with hospitals, Vital Records, State Department of Health, Family and Social Services, and other agencies, we can greatly reduce the number of missing persons in Indiana.





Poster Contest, con't

Some important facts about the contest:

- There is NO LIMIT on the number of posters a school can submit;
- Only one (1) poster per student is allowed for submission;
- Students who submit posters MUST be in the 5th grade;
- Artwork should reflect the theme “Bringing Our Missing Children Home.” This phrase MUST appear somewhere on the poster;
- The finished poster MUST measure 8.5 x 14 inches;

- A COMPLETED application must accompany the poster;

Get Involved: CyberTipline

The National Center for Missing and Exploited Children (NCMEC) [CyberTipline](#) is the nation’s centralized reporting system for the online exploitation of children. The public and electronic service providers can make reports of suspected online enticement of children for sexual acts, extra-familial child sexual molestation, child pornography, child sex tourism, child sex trafficking, unsolicited obscene materials sent to a child, misleading domain names, and misleading words or digital images on the internet.

NCMEC staff review each tip and work to find a potential location for the incident reported so that it may be made available to the appropriate law-enforcement agency for possible investigation. We also use the information from our CyberTipline reports to help shape our prevention and safety messages.

JA'NIYAH MCMICHAEL is a 13-year-old female, 4 feet 3 inches tall, with black hair and brown eyes.

Ja'Niyah is missing from Gary, Indiana which is 151 miles northwest of Indianapolis and was last seen on August 11, 2024.

ELLA SAYLOR is a 15-year-old female, 5 feet 4 inches tall with brown hair and brown eyes.

Ella is missing from Muncie, Indiana which is 60 miles north-east of Indianapolis and was last seen on February 3, 2024.

Silver Alert Criteria

For a Silver Alert request to be taken into consideration, the following criteria must be met:

1. The person must be a Missing Endangered Adult (I.C. 12-7-2-131.3), a Missing Endangered Child (I.C. 10-13-5-4.4), a High Risk Missing Person (I.C. 5-2-17-1), or have a mental impairment validated through a credible medical authority (MD, PA or NP).
2. There must be enough descriptive information to believe the broadcast will help.
3. Request must be recommended by the law enforcement agency of jurisdiction.
4. Enter the person into IDACS/NCIC with message key EME.

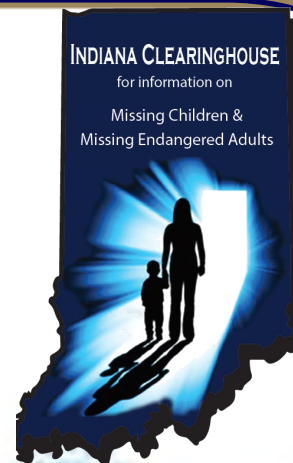

The Missing Person Bulletin is a valuable resource available for you to check and confirm if a person is identified as missing in the State of Indiana. The bulletin is updated daily Monday through Friday with information from the National Crime Information Center (NCIC) and the Indiana Data and Communication System (IDACS). Always check the date at the bottom of the page to confirm when the bulletin was last updated. If there is any doubt, feel free to call the Clearinghouse at 800-831-8953.

National Center for Missing and Exploited Children (NCMEC)

The mission of the National Center for Missing and Exploited Children is to help find missing children, reduce child sexual exploitation, and prevent child victimization. They operate a 24/7 national hotline (1-800-THE-LOST) for tips and reports related to missing and sexually exploited children, create and distribute missing child posters, redistribute AMBER Alerts, operate the CyberTipline for child sexual exploitation, help locate victims of child sex trafficking, assist law enforcement with tracking non-compliant sex offenders, provide crisis intervention and counseling referrals, and ensure that victims of child sex trafficking have access to the recovery services and support they need.

National Runaway Safeline

The mission of the National Runaway Safeline is to help keep America's runaway, homeless, and at-risk youth safe and off the streets. Funded and administered by the National Institute of Justice and managed through a cooperative agreement with the UNT Health Science Center in Fort Worth, Texas, all NamUs resources are provided at no cost to law enforcement, medical examiners, coroners, allied forensic professionals, and family members of missing persons.

Who we are



The Indiana General Assembly established the Indiana Clearinghouse for Information on Missing Children and Missing Endangered Adults in 2009. The Clearinghouse is intended to serve as the state central repository for all information on missing children and missing endangered adults from Indiana or believed to be in Indiana. The program is designed to collect, store, and disseminate information on missing children and missing and endangered adults. The Clearinghouse provides liaison among citizens, private organizations, and law enforcement agencies regarding missing children information.
